## 1812: Updates from Admiral Alfultis

- Updates on the following: Regimental External Review, Fiscal Situation, SUNY mandate for fiscal responsibility.
  - Regimental External Review Released on March 2024; On Spring of 2022 there was cadet focused group. Which they reviewed and prioritized there external review.
  - Cadet Leadership has had 20 action and initiatives.
  - Cadet focused group will continue; address the change and the school is doing the work.
- Struggles on enrollment and budgets:
  - Start of the academic year had the Path of Fiscal wellness with the four pillars are:
    - Carefully manage our cost and expidentures
    - Increase revenue from alternative sources
    - Increase federal and state support
    - Increase enrollment
  - Making progress in all areas.
- Selected a new mariner in director of professional development James Spear.
- Received 1.2 million dollars in grant in offshore wind. NYS only operational training center.
- Estimating in 2 million dollar in revenue
- Raising funds in our games funds.
- Federal Government is fully funding the fuel for Summer Sea term. Last year we received 1.1 million dollars.
- Senate Bill has 4 million dollars for the summer sea term.
- Admirals position for the next president is for them to lean support on additional support for summer sea term and reduce the cost of the license program, to allow them to be achievable for more new Yorkers. We need to continue the narrative of making the program equitable and desirable for new Yorkers. Allow the state budget to cover the personnel, feds cover the fuel, then the only thing left is the tuition, room and board.

- At least 400 new students last Saturday and with a total of 1000 students in campus. Retention numbers are back to pre covid numbers.
- Working with the alumni association on the Admiral farewell tour. Next one is Houston and New Orleans. The future of the relationship with the college and the alumni is stronger.
- Proud of the accomplishment that we have achieve through getting the new ship, setting up the foundation, getting through covid, and strengthening the alumni association relationship.
- The Coast Guard was here last Wednesday, and they were in awe of the ship.
- To promote the opportunities that the college provide, and we will do great with enrollment numbers.
- Update on the training ship: the plan is working well down below. The issue is internet and spare parts.
- Staffing issues. Captain Morgan has a list of what he needs.
- DOT and MARAD network issue.
